## SCOPING COMMITTEE FORMING FOR HEALTH IMPACT ASSESSMENT

The North West Alliance met yesterday in Bellata with participants from across the New England and North West. A major topic for discussion was progress on the formation of a Regional Task Group to conduct a Health Impact Assessment in the Gunnedah Basin.

A resolution to conduct a Health Impact Assessment into the individual and cumulative effects of coal seam gas and the expansion of coal mining, was carried by community members at the Health Forum conducted by the Alliance in Gunnedah on August 4<sup>th</sup>. Forum attendees were adamant that no negative health impacts resulting from these industries would be tolerated, reflecting concerns reported from the CSG fields in Tara, Queensland, and the high incidence of respiratory disease and cancer clusters recently reported in the Hunter Valley and Newcastle.

Phil Laird, from Maules Creek Community Council gave a brief overview of the process of a Health Impact Assessment, which uses a combination of methods and tools by which a policy, programme or project may be judged as to its potential effects on the health of a population.

"Formation of a Scoping Committee to decide the Terms of Reference of the Health Impact Assessment is the first step in this process. Members of the Scoping Committee may well continue on as part of the project" said Mr Laird.

Nicky Chirlian, from Save Our Soils Liverpool Plains, reported that Expressions of Interest for members of the Scoping Committee have been sent out widely, including to all local councils, community organisations and Hunter New England Health.

"A range of qualifications for members of the group are required, including health, government, finance, and media skills. We are also seeking representatives from communities across the region and across cultural, employment, and business sectors." she said.

"A number of applications from community members with qualifications in law, health, business, and project management have been received to date, and that more enquiries are welcome."

An initial meeting to develop the Terms of Reference by the Scoping Committee is planned for mid September.

- Political/Government/Corporate Background

- Familiarity with the proposed developments in the region

- **4 organizations or professionals**: Representatives from Mining related Councils; Hunter New England Health; General Practitioner, Nursing, Mental Health Professional Chartered Accountant, Lawyer or Corporate Manager
